- Compliance report of the conditions mentioned, if any, in the letter issued by State Govt./ Inspection Report of the University duly supported with documental evidences.
- Report on the compliance of the State policy relating to eligibility criteria for the admission of students b) duly supported with documental evidences.
- Certificate of the AISHE registration and uploading of up to date information on AISHE portal. c)
- Certificate that all financial transactions are done in the digital mode duly supported with documental evidences.
- Certificate of accreditation by NAAC/applied for accreditation by NAAC for college which has completed two Academic sessions.
